When displaying at Arts in the Park, you must provide your own canopy in case of inclement weather. Although we will attempt to honor requests, the committee will make space assignments based on the date the application was received and the type of medium. Due to the increased number of artists that are displaying their medium outside the given booth space, we have decided to increase the booth space and allow **no one** to display outside of their area. The exhibition space will be **measured** to a 12' X 12' area. Please keep in mind that with the increase in booth space, the booths will shift (as they do every year). If additional space is needed, you must indicate that request on your entry form and pay the appropriate fee.
